When the first settlers arrived in what was to become Palm Beach, the entire area was known as "Lake Worth", named for Major General William Jenkins Worth who fought in the Second Seminole War. The first of the permanent pioneers arrived in 1872. According to early settler accounts, Palm Beach received its name from a shipwreck named the "Providencia." The ship washed ashore in January 1878 with a load of coconuts bound from Havana to Barcelona.

Word of the area's beauty spread northward and by the early 1890s the island community was well established with several hotels, businesses, and winter residents. The pioneer era ended in 1894 with the opening of Henry M. Flagler's Royal Poinciana Hotel and the arrival of the Florida East Coast Railroad in 1896. The Town of Palm Beach was incorporated on April 17, 1911. In 1929, the Garden Club of Palm Beach sponsored the preparation of a Town Plan.

After over 100 years of graceful evolution, Palm Beach today is a fully developed community, world-renowned for its beauty, quality of life and small-town character. It is home to "Captains of Industry" and the world-famous Worth Avenue. Approximately 9,000 citizens make Palm Beach their year-round home, and about 20,000 more have a seasonal home in Palm Beach where they enjoy the winter months. Together, these residents of Palm Beach donate more money per capita to charities than any other community in America.

This position is responsible for the administration, direction, supervision and operation of the Planning, Zoning & Building Department, reporting directly to the Town Manager. The Planning, Zoning and Building Director responsibilities include, and are not limited to:

- Administration of the department's operations and supervison of direct reports
- Ability to engage employees through teamwork and motivation.
- Ensures all operations of the Department are in compliance with Town, State, and Federal policies, requirements, and regulations
- Makes decisions for disciplinary actions, hiring, and termination of assigned personnel, consulting with the Town Manager as needed.
- Overall department leadership in a manner that supports the Town's mission and values.
- Fosters a service-minded collaborative environment.
- Prepares annual budgetary estimates, monitors annual budget expenditures, and identifies opportunities to improve efficiencies and/or reduce expenses while maintaining expected service levels
- Attends all Town Council and Town Commission meetings as related to Planning, Zoning, and Building matters.
- Supervises review of plans and makes final decisions as to the conformance and specifications to the governing laws and the application of the planning, zoning and building laws to questionable cases.
- Oversees of the Town's comprehensive planning process.
- Maintains current knowledge and practices of the State Comprehensive Planning law.

- Makes field inspections, as necessary.
